### **2023-24 Unit Record Revisions, Updated Edits, and Clarifications**

Revisions, edits, and clarifications have been deployed across collections. Revisions were made to update collections to capture additional data required to enhance MHEC's research agenda, to more accurately report on institutional data, and to prepare for Maryland's Blueprint future implementation. Additional edits were coded to assist with identifying and eliminating errors in file submissions. Please note that variables that were optional to report for 2022-23 are required for the 2023-24 collection year. The required variables are identified on the layouts. Clarifications are intended to offer more detailed guidance for certain data elements that tend to frequently trigger errors because of inaccurate reporting or formatting.

All final data cookbook changes have been completed. Please note that data cookbook revisions have been ongoing since May, but changes have occurred since that time.

New data elements, new codes, and required variables for 2023-24 are listed below. All new elements are optional to report for the 2023-24 year and required for the 2024-25 collection year. Although the field may be optional, a value for the field is still required.

- **Campus Climate Survey Narrative Report and Sexual Assault Incident Data** - For the 2022-2024 cycle, guidelines, a revised data collection tool and other materials were distributed in September 2022. Institutions should use those materials for the 2024 submission. The next submission date is June 1, 2024.
- MHEC is no longer collecting aggregated enrollment surveys from private institutions. The 2022-23 collection year was the last year MHEC will collect aggregate degree and aggregate financial aid data from private institutions. Private institutions have fully transitioned to submitting unit record data collections during the 2022-23 collection year and will continue to do so for 2023-24 and beyond.

## Other Important Notes

- MHEC will no longer accept collection files with spaces between commas. If a data element is not reported, there should be successive commas in the csv file, NOT a space between the commas. The file will be promptly returned to the institution for corrections.
- MHEC will classify all state mandated tuition waivers or tuition exemptions according to the codes listed in the FAIS Aid Category Code chart. State mandated tuition waivers must be reported under the correct code rather than as generic "institutional grants" or "institutional scholarships." When reporting aid by institution, MHEC will include the waivers in the institutional aid category as a state mandated tuition waiver or tuition exemptions. These include: Foster Care Tuition Waivers/Tuition Exemptions, Homeless Youth Tuition Waivers/Exemptions, Senior Citizen Tuition Waivers/Exemptions; Student Tuition Waivers/Exemptions; Employees and Dependents Tuition Waivers/Exemptions. These tuition exemptions/waivers CANNOT be classified as institutional aid or other forms of aid for FAIS reporting purposes.
