MARYLAND HIGHER EDUCATION COMMISSION ANNUAL REPORT ON EXEMPTION FOR NONRESIDENT TUITION FOR UNDOCUMENTED IMMIGRANTS (§15-106.8)

Effective December 6, 2012, Education §15-106.8 exempts undocumented immigrants, who provide the requisite information and meet the specified qualifications, from paying out-of-state tuition at Maryland's public community colleges and four-year institutions. According to subsection (f), the Maryland Higher Education Commission is required to collect "the number of individuals who pay the tuition rate in accordance with the requirements" of Education §15-106.8 and submit a report to the General Assembly. Therefore, it is requested that all public institutions complete the S-20 survey form and return it to MHEC by July 15, 2023. In addition to the number of individuals receiving the exemption, the Commission is also asking institutions to provide the total amount of dollars that students saved by this exemption. (Note: these calculations should include tuition only, rather than tuition and fees.)

Community Colleges and 4-Year institutions are required to complete and submit this form.

Instructions: The reporting period ends June 30 and we ask that the submissions are turned into MHEC by July 15. This deadline assumes that: all enrollments defined as Summer term are classified on a leading-summer basis, rather than a calendar basis; all course enrollments defined as Spring term are concluded prior to June 30; all tuition charges for any course defined as Spring term are assessed before June 30.

Instructions for terms: Please include the Numbers and Dollars for the TERM as defined by your institution. For example, add all counts and dollars for all summer terms based on summer sessions as defined by your institution. If the term does not apply, please indicate 0.
