

# S-35 Tuition Waiver for Victims of Human Trafficking - Due August 1, 2024

Section 15-106.1(d) of the Maryland Education Article requires that community colleges report the number of recipients of the Victims of Human Trafficking Tuition Waiver to the Maryland Higher Education Commission each year.

The statute requires the collection of the number of recipients who received the specified tuition exemption during the prior academic year. The legislation requires that the Commission submit a report to the General Assembly annually. Therefore, all community colleges must complete this survey and submit it to MHEC by August 1st.

If your institution has a policy to award tuition waivers to victims of human trafficking, you are required to provide the count (insert a "0" if none have been awarded) and upload your policy in PDF format. If your institution has not adopted a policy, you are required to complete the form, respond "no" to the policy question and submit.

**Reporting Cycle:** Of the students enrolled in the reporting year, please report the count of tuition waiver recipients who received the specified tuition exemption during the reporting year (July 1, 2023 to June 30, 2024).

**Policy Reporting Cycle:** Upload your policy in PDF format regardless of the year of policy implementation. All institutions with a policy should upload a copy, not just those institutions that implemented a policy in the reporting year.
